The colleges within the Grossmont-Cuyamaca Community College District (GCCCD) administer their intercollegiate athletics programs in accordance with the rules and regulations adopted by the California Community College Athletic Association (CCCAA) and all applicable conferences. ~~In addition to the student-athlete eligibility requirements found in the CCCAA Constitution and Bylaws, student-athletes must observe GCCCD Standards of Conduct which are found in BP & AP 5500, Standards of Student Conduct.~~

~~Each student-athlete meets annually with Athletics Department staff to review applicable rules and policies.~~

~~As a multi-college district each institution will adhere to CCCAA Bylaws 1.9.1 and 1.9.2 which govern student-athlete eligibility for those students who participate in intercollegiate athletics and attend one or both institutions. In addition to the aforementioned Bylaws, student-athletes will also be subject to CCCAA Bylaw 1.10.1 as it relates to the transfer from one institution to another in a multi-college district when both colleges sponsor the same sport. To become eligible the student-athlete must complete 12 units in residence (only 8 units from summer) at the other institution before they can becomeing eligible to participate.~~

~~TheEach athletic director will conduct an annual in-service for all athletic department staff no later than the last Friday in August.~~

~~Each student-athlete meets annually with Athletics Department staff to review applicable rules and policies.~~

#### **Compliance**

~~Each Athletic Director annually completes the Statement of Compliance, Title IX Gender Equity (Form R4) and maintains the report in the Athletics Department.~~

~~At least once within every five (5) years, the CCCAA and the Pacific Coast Athletic Conference (PCAC) conducts a Program Review of each college's athletic department.~~

~~The athletic director will conduct aAn annual in-service for all athletic department~~

staff is conducted by the Athletics Department no later than the last Friday in August.

Each October each Athletic Director will complete and submit a mandatory Federal survey (the Equity in Athletics Disclosure Act of 1994) to the U.S. Department of Education.

The Athletic Director is delegated authority from the Vice President for Student Services for developing, implementing, and monitoring the foregoing procedures.
