Additions to Agenda

Lastimado announced a Tentative Settlement Agreement with United Faculty. Close stated faculty was pleased with the settlement and is looking forward to Governing Board approval.

Cuyamaca EIR

Austin stated the District will be reimbursed attorneys fees of approximately \$56,000 for the County's lawsuit concerning the Cuyamaca College EIR.

Review of November 15, 2005, Regular Governing Board Meeting Agenda

Suarez presented the November 15, 2005, regular Board meeting docket for review.

- Item 115 Employment Contracts for Administrators. Tiffany requested that the item be pulled from the docket due to issues regarding the duration of the contracts and representation issues. Lastimado stated this is a meet and confer process inline with PERB requirements, and can be pulled later for modification. Suarez stated the item will move forward, and will meet with Tiffany regarding issues.
- Item 203 Re-Naming District Facilities Grossmont College Life Safety Road Streets. Council discussed a title change to Re-Naming District Facilities Grossmont College Road and Streets.
- Item 303 Ratification of Signatures on Agreements. Austin distributed attachment A.
- Item 700 Public Presentations was discussed to clarify white and blue cards.

Austin reported on budget, finance, and public works items. Lastimado reported on personnel items.
