# Review of October 18 Regular Governing Board Meeting Agenda

Lastimado presented the October 18, 2005, regular Board meeting docket for review.

Council discussed the Chancellor's Classified Senate Award. Murray explained the awards will be presented Quarterly, beginning January.

Quittner stated there will be an addition of a resolution for Equalization to the agenda. Quittner recommends support for \$240 million for Equalization, as originally proposed by the Governor.

Rearic reported on budget and finance. Joe Minner reported on public works items. Lastimado reported on personnel items.

## **District Facilities**

Quittner distributed a highlighted copy of the *Grossmont-Cuyamaca Community College District Facilities Fact Sheet* showing areas revised. Revisions relate to funding which was changed to projected and preliminary costs estimates for projects currently under construction. Quittner stated two big changes in the Fact Sheet are: 1) The parking construction projects for both colleges; and 2) The separation of the Student Services Building and the Student Center for Grossmont College, reflecting action taken by the Governing Board on the preliminary costs estimates for both buildings.

Action: Quittner to distribute District Facilities Fact sheet districtwide.

#### Legislative Update

Quittner reported Governor Schwarzenegger signed legislation to waive non-resident fees for Hurricane victims. Quittner stated the Governor discussed legislative programs for the coming year. The Governor vetoed Equipment Fees for damaged equipment because there was no cap on the fees, and Governor signed the Student Health Fees legislation. The Governor discussed the next bond, and/or whether there will be a bond for next year. Quittner stated the District is seeking the same specifics as before, 40% for community colleges and a 30% escalation clause that will allow the District funding for increased costs. The CEO Board endorsed a community college initiative for the Fall 2006 ballot, to reduce fees from \$26 to \$20.
