> Status of Legally Required Policies and Procedures

 - Clarify that the policy covers students, employees, and the public.
 - Ensure that exceptions include:
 - Requests for children to participate in classes (such as models for photo classes)
 - Student services and library facilities on each campus
 - Include all previous revision tracking on each draft.
 - In-depth attorney review of the policy and procedure.

Rearic will review CCLC recommended wording and other districts' policies and procedures.

- As a result of conversations on AP/BP 3840 Children on Campus, the Chancellor directed the college Presidents to confirm that appropriate procedures are in place for requesting models, and children in particular, in the classrooms.
