Cultural Competency     Training for DEI Task Force	Some members of this committee attended Raad Jerjis' outstanding workshop. Suggestion for retreat leader: Dr. Edwina Welch who manages the Cross-Cultural Center at USC; available the last week of July, first week of August. Her questions:  • What is our driving theory? • Questions we might have? • Committee Charge? • Key players? • One-half day training or full day?  Dr. Welch would then perform a site visit (1-2 hours) and deliver the training.  Augustin will join Cultural Competency Workshop Subcommittee,
	since Raad Jerjis and Francis Steindorf are off campus for the summer. In the fall Augustin will recruit another member from GC for this committee. Nancy Jennings volunteered to assist this group, as well.
