Subject: NONRESIDENT TUITION FEE FOR 2013-2014 Date: JANUARY 15, 2013

1. PROPOSAL

Grant authority to the Chancellor to establish the nonresident tuition fee at the highest of four prior years' statewide average tuition of \$190 per unit for fiscal year 2013-2014 beginning with the fall term.

2. INFORMATION IN SUPPORT OF PROPOSAL

a. Summary of Issue

Education Code Section 76140 requires that the governing board of a community college district set the nonresident fees each year for the following fiscal year.

Nonresident tuition applies to both out-of-state students and international students. In addition, the Education Code allows the District an option to charge international students an additional capital outlay fee and/or a processing fee.

b. <u>Background</u>

(1) Nonresident tuition:

The District has seven options for the nonresident tuition:

- 1. Use the statewide average cost of \$190:
- **2.** Use the District average cost of \$194;
- 3. Use the District average cost with 10% or more noncredit FTES (N/A);
- **4.** Charge a fee consistent with a contiguous district within the range of statewide average and District costs; or
- **5.** Charge a different fee within the same range:
- **6.** Use the highest of four prior years' statewide average tuition of \$190;
- 7. Use no more than 12 comparable States' average tuition of \$368.

If option (6) or (7) is used, it is the responsibility of the District to ensure and document that the additional revenue generated by the increased nonresident tuition permitted under option (6) or (7) shall be used to expand and enhance services to <u>resident students only</u>, per Education Code Section 76140(e)(2).

The District average cost fee is the minimum amount the District can charge, and the statewide average cost fee is the maximum amount the District can charge for 2013-2014. Beginning in 1996-1997, in the District allocation formula, the nonresident tuition is dedicated as local income for the college that generates it.

> In addition to the nonresident tuition, these students are also required to pay the mandatory California enrollment fee.

(2) Capital outlay fee for international students:

According to the Education Code, each district may charge international students an amount for capital outlay, however, these funds must be used for capital outlay, maintenance, and equipment. This amount cannot exceed the amount that was expended by the district for capital outlay per full-time equivalent student in the preceding fiscal year. The District chooses to not charge the capital outlay fee.

(3) Processing fee for international students:

Additionally, the Education Code authorizes each district to charge international students a processing fee, not to exceed \$100. Such fees are nonrefundable to students who do not register. However, this fee would be offset against tuition at the time of registration for those students who do register. In prior years the administrations of the colleges have determined that it is not necessary to charge this fee. This year it is again recommended to not charge this fee.
