
DSP&BC Evaluation Survey Results, Fall 2013

Feedback regarding charge and membership

- 1. The council seems to work as a very cohesive and cooperative group. The size and membership is appropriate to the work performed.

Feedback regarding committee meetings

- The length of the meetings is appropriate to cover the agenda. The participants' questions/concerns are
 addressed during the meetings, with follow-up information to be provided as necessary. The environment and
 tone seem to be comfortable and conducive to free expression of ideas and the discussion of issues.
 Transparency of information appears to be a clear goal of the DSP&BC. The minutes are not always posted in
 a timely manner; but there may be a good reason for the delay.

- 3. I believe the meetings times are the appropriate length. I think we should format the meetings so that items that require discussion, deliberation or some sort of action are placed first on the agenda, and items that are for information only should be placed at the end of the agenda. This way we get to the heart of the meetings first and if we run late the informational items can be postponed or simply provided to the council members to read on their own.
- 4. seems like one way dialog sometimes but it might be the complexity of the budget stuff and the formatting of complicated spreadsheets. It's a big group and sometimes it's hard to hear all the speakers so microphones, standing up and projecting might help.
- 5. Sometimes it is unclear when you want feedback from the Council and when you are merely informing us. It's clear an enormous amount of preparation goes into the budget reports for the meeting. As with every meeting, it would be helpful to reiterate any decisions we've made at the end of the discussion and confirm what the next steps are.
- 6. There are times which I think the Council does NOT have enough time to fully discuss all the different matters presented at the meeting or discussion is being cut short because of the time issue.
- 7. Meetings stay within the schedule and the time is appropriate for the amount of information presented.

Feedback regarding committee participation

- I. I feel comfortable to speak freely and express concerns during the meetings. The Chancellor does an excellent job in setting an inclusive and supportive tone for the meetings. The Vice Chancellor and Associate Vice Chancellor, Business Services both do an outstanding job of providing clarification and further explanation of all presented information. The council members who are also partipants in other councils/committees seem to have an especially good grasp of the presented information. Follow-up requested in prior meetings is identified and provided as appropriate.
