


## **Unduplicated Student Headcount**


Since the start of registration, unduplicated student headcount districtwide has reached 18,602 students (CC: 8,581; GC: 13,769).

At one week after the start of the term, unduplicated student headcount has increased by 8.7% percent from Spring 2023 totals (CC: 7.3%; GC: 8.2%).




## **Productivity**


Figure 3: Overall Spring Enrollments and Fill Rates, 2022-2024 (I Week After Start of Term)


Since the start of registration, FTES for residents has reached to 6,862.04 districtwide (CC: 2,447.02; GC: 4,415.02).
