

Grossmont-Cuyamaca Community College District 2020-21 Nonresident Tuition and Capital Outlay Fee

Education Code section 76140 requires each district governing board to establish the nonresident tuition fee for the following fiscal year

Nonresident Tuition Fee

The district has seven options for the nonresident tuition:

- Option 1 District Average Cost
- Option 2 District Average cost with 10% or more noncredit FTES
- Option 3 Statewide Average Cost
- Option 4 Highest Statewide Average Cost
- Option 5 An amount not to exceed the fee established by the governing board of any contiguous district
- Option 6 An amount Between Statewide Average Expense of Education & District Expense of Education
- Option 7 No more than 12 Comparable cost of living States' average tuition

Nonresident Capital Outlay Fee

The District may charge a capital outlay fee to nonresident students:

- Option 1 District capital outlay expenditures in the preceding fiscal year divided by total FTES
- Option 2 Fifty percent of the nonresident tuition fee adopted by the district

Note: Palomar College charges \$5/unit for capital outlay fee

Processing Fee for Students from Foreign Countries

The district may charge nonresident applicants who are both citizens and residents of a foreign country a processing fee not to exceed the lesser of

- (1) the actual cost of processing an application and other documentation required by the federal government
- (2) \$100

This fee may be deducted from the tuition fee at the time of enrollment

Note: San Diego Community College District charges \$100 processing fee
