  - Status of Whiteboard: Whiteboard is recommended to open in a new window. Deb is working with the company to get this working on the test server, but the company has not been able to so far. One caveat is that the 'open in new window' setting required an install of a third party Building Block (Basic LTI Tool from OSCELOT). It is not known if this Building Block will interfere with the Blackboard LTI used for Smarthinking, but so far it doesn't seem to be a problem. Note: Nettutor opens in a new window automatically without additional settings.
  - Archiving & Deletion of Old Containers GC agreed to retain 7 semesters as approved by CC. GC will take this item to IAC, TTLC, and Distance Learning Committees. Instructors are also able to archive their own containers. There is a question of compatibility when restoring older archived containers to newer versions of Blackboard.
