



**MEMORANDUM OF UNDERSTANDING**  
between  
**GROSSMONT-CUYAMACA COMMUNITY COLLEGE DISTRICT**  
and  
**ANGLO-AMERICAN UNIVERSITY**

The intent of this memorandum of understanding (MOU) is to provide opportunities for baccalaureate completion at Anglo-American University (AAU) for associate degree graduates of Grossmont-Cuyamaca Community College District (GCCCD).

AAU, a private not-for-profit university located in Prague, Czech Republic, is accredited by the WASC Senior College and University Commission (WSCUC), as well as by the Czech Republic Department of Education (EU compatible). All instruction is conducted in English, and the cost of tuition and living expenses is currently less than that for attending a California State University. Additionally, AAU's baccalaureate completion degree offers an accelerated pathway requiring only 45 credits beyond the associate for aligned programs or 54 credits for non-aligned programs. An additional opportunity for interested GCCCD employees or alumni is the option for an affordable, high-quality MBA in Prague offered through Chapman University/AAU.

GCCCD and AAU hereby agree to enter into the following educational collaboration agreement:

1. GCCCD and AAU will work together to identify which Grossmont and/or Cuyamaca College degrees are aligned/non-aligned with AAU bachelor's degrees.
2. GCCCD and AAU will have permission to utilize online links and college/university publications for a period of three (3) years.
3. GCCCD and AAU respective logos can be used for marketing this partnership for a period of three (3) renewable years.
4. GCCCD will assist in identifying well-qualified associate degree recipients from GCCCD.
5. GCCCD will assist in promoting the AAU opportunity through its web and social media outlets.
6. AAU will issue acceptance letters to GCCCD students at least two (2) months in advance of the start of the term.
7. AAU will continue WASC accreditation as long as students are attending AAU from the U.S.
8. AAU will provide referrals for housing and "Experiencing Placements over Europe (EXPLORE)" Erasmus or similar support programs for U.S. students.
9. This MOU will be reviewed for re-authorization in Spring 2021. At any time, and for any reason, both entities retain the right to terminate this MOU.
