Technology Coordinating Council (TCC)

Charge:

Provides vision, strategy, policy and planning recommendations for the adoption, implementation and maintenance of existing, new and emerging technologies. Serves in an advisory capacity to the District Executive Council concerning strategic direction, policies and recommendations for enterprise systems and technology. The council also provides the following:

- Recommendations to District Executive Council regarding vision, policy, planning and strategy regarding districtwide technology efforts
- Recommendations for policies and strategic priorities related to enterprise systems and technology and development and monitoring of the Information Technology Plan for enterprise systems, administrative computing, and instructional technology districtwide
- Communications on enterprise systems and technology status to stakeholder groups and existing councils and committees
- Communications regarding project prioritization and status with the Technology
 Advisory Committee (TAC). Receive information regarding priorities established by the
 TAC and provide feedback regarding those priorities
- Communications regarding technology initiatives from the College Technology
 Committees. Receive recommendations from the College Technology Committees
 regarding districtwide projects and forward to the District Executive Council as
 appropriate
- Provide quarterly updates to the District Executive Council on districtwide technology
- Coordinate technology improvements at each site for consistency of services to students and employees

- Provide regular updates regarding district wide technology projects to the TCC regarding project prioritization and status
- Recommend processes and prioritization related to the selection, implementation, and operation of administrative and instructional information technology.
- Assist in the creation and execution of the Technology Plan.
- Provide communication and consultation to constituent groups and existing councils and committees regarding administrative and instructional technology as requested
