Workday Terminology

With the Workday implementation project well underway, we continue to learn new concepts and words. Here are a few we have been introduced to:

- Business Process A sequence of one or more tasks that accomplishes a desired business objective, such as hiring an
 employee or paying an invoice; a.k.a. workflow.
- Search Use the Search window to locate any tasks, reports, and views within Workday, to which you have access.
- Worker A person who is either an employee hired by GCCCD or a contingent worker contracted by GCCCD.
